End User License Agreement

This End User License Agreement ("Agreement") is a legal agreement between you (either an individual or a single entity) (collectively "You") and Russian3DScanner LLC ("R3DS"), a company registered at Lomonosova 114/12-8, Voronezh, Russia, 394087, for the Wrap4D software product.

BY DOWNLOADING AND/OR USING ALL OR ANY PORTION OF THE SOFTWARE YOU ACCEPT ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE, DO NOT USE THE SOFTWARE.

1. DEFINITIONS

"Software" means the R3DS proprietary software product Wrap4D, licensed to you under this Agreement. The term "Software" shall also include any documentation, upgrades, modified versions, updates, additions, and copies of the Software licensed to you by R3DS, if any.

"License" means the limited right to use the Software as detailed in this Agreement.

"User" means an individual person who is authorized by R3DS to use the Software.

"Legal Entity" means any company, corporation, limited liability company, general partnership, limited partnership, limited liability partnership, proprietorship, joint venture, or other form of business organization, and includes, without limitation, any government, non-for-profit, educational, or academic institution, including but not limited to any primary or secondary school, vocational school, college or university.

"Perpetual License" means a License to use the Software for unlimited period of time. Maintenance is included in the first 12-months period, and then offered on an optional basis. Additional maintenance may be purchased on the R3DS website. Maintenance provides most recent Software updates. The annual maintenance fees are fifty (50) percent of the price of the Perpetual License at the time of purchasing the maintenance.

"Evaluation License" means a License granted to a User for a limited duration, to enable the User to evaluate the Software and to determine whether to purchase a version of the Software. The use of an Evaluation License for commercial, professional, or for-profit purposes is forbidden.

"Sample Data" means 3D models, 3D scans, and images provided to You by R3DS. The Sample Data is included into the Software distributable and available for download from R3DS website.

2. LICENSE
